The **Non-NEET UG Merit List** for other medical and allied courses has also been uploaded on the Department's website and displayed on the Notice Board.

IMPORTANT INSTRUCTIONS

1. Candidates are advised to carefully verify the particulars furnished in the merit list, including their **Name, Father's Name, NEET Score, and ST Rank.**
2. In case of any discrepancy, candidates shall submit an application for correction/clarification to the office of the undersigned **on or before 5th August, 2026 (Wednesday), during office hours.** Requests may also be submitted through:

3. No change or addition of course in preference shall be permitted.
4. The minimum qualifying NEET (UG) score for **Scheduled Tribe (ST)** candidates is **177 marks.**
5. The Department has become aware of instances where candidates have submitted tampered or fabricated NEET scorecards. Such actions constitute a serious offence and may result in cancellation or debarment of candidature, along with appropriate legal action.
6. **Rejected List** candidates may verify the remarks for reasons of rejection. Candidates may submit any pending or corrected documents, including **Class XII re-appeared mark sheets, certificates, or other relevant documents** on or before **5th August, 2026.**
7. No request for correction, clarification or submission of documents shall be entertained after the stipulated last date, i.e., **5th August, 2026.**
8. The schedule for **State NEET and Non-NEET Counselling** shall be notified later through leading local newspapers and on the Department's website: www.dte.nagaland.gov.in.
